



- a) The Trust shall mean "Shri Krishna Charitable & Educational Trust" and its successors and interest.
  - b) The trustees shall mean the trustee of the trust.
  - c) The general Body means all trustees and those appointed under this trust.
  - d) The Treasurer means the Treasurer of the Trust.
  - e) The Secretary means the Secretary of the Trust.
4. Objectives

- a) Advancement promotion and spread of education science, art, literature and the Establishment maintenance and support of collages, Schools, educational institutions, hostels, libraries reading rooms or others educational institution.
- b) To spread Education in any part of India. To sponsor, open, take over, Establish, maintain, promote or run education such as schools, Management, Environmental Science, Medical Engineering, Dental, Veterinary Allied Subjects collage, institutions, Para Medical Courses Schools, Clinics, Academics, Laboratories, and Indian Science Institutions & open Deemed University/ Private full fledge University recognized.
- c) To publish, books, magazines, periodicals, or other literature in any field or education including translation of foreign publications. In this connection to take or buy copyrights any book or publications and to print such book or publication in the name of the Trust.
- d) To train bring up students according to ancient Indian Culture and to give them education according to the Modern and Scientific Methods.
- e) To work for the removal of social evils such as untouchability illiteracy and interference among the students from their childhood.
- f) Medical relief and /or maintenance of the sick and /or establishment, maintenance, support of or donations of one or more hospitals, dispensaries, nursing homes, medical centers and utilization of funds for medical relief of all kinds.
- g) Relief to the poor stricken with calamities such as earthquakes, floods droughts famines fire riots or otherwise.
- h) Relief and help to the aged, blind, lame, deaf, dumb, orphans and persons otherwise disabled or incapable of earning their livelihood or any one or more or them for the benefit of such persons.
- i) To sponsor, open, establish, maintain aid, promote elders home, boarding house for the benefit of students, sanskrit, pathshalas, crest house, widows homes, Gashala cow sheds authority for promotion of education, literature, science, fine arts, crafts, sports and cultural activities.
- j) To undertake, carry out, promote, establish set up, conduct aid help or otherwise support sponsor rural development and uplift including any programmer for prompting the social and economic welfare or, or the uplift of the public in any rural area and to incur expenditure on any programmer of rural development and to assist and help execution and promotion thereof either directly or through an independent agency.
- k) To undertake the work or conservation of natural resources and support or assist Institution carrying out plantation work.



- l) To undertake the work or conservation of natural resources and support of any Institution carrying out the work or conservation of natural resources.
- m) To impart education by opening any institutions, school, collage etc.
- n) To establish maintain and run studentships, scholarship and render other kind of aid to student including supply of books stipends medal and other incentives to study without distinction as to caste colour creed or sex.
- o) To assist and support other institutions having similar objects or advancement of this trust.
- p) The Trust may apply to any financial Institution / Nationalized bank to get loan to achieve the objects of the trust.
- q) Any other object of general public utility.
- r) To accept donations, grants, presents, gifts, and other offerings in the shape of money and / or immovable properties for the attainment of objective of the trust.
- s) To hold and conduct classes, lectures, conferences, seminars, competitions, scholarships diploma certificate as and when deem fit.
- t) To set up, establish maintain and manage centers for the study of agricultural rural medical care, handicrafts, communication and also run cottage industries for the benefit of physically, mentally, society or otherwise handicapped individuals to benefits people of all religions, caste and communication.
- u) To establish schools and home for the physically handicapped and mentally retarded children.
- v) To purchase /Lease / acquire the land and / or the building in the name the trust for upliftment of the objective of the trust. To open branches of the trust at any place in India.
- w) To invest its money and funds according to the section 11 (5) of the income tax Act 1961 and apply and get registration with income tax dep't.
- x) To erect , construct, alter, maintain, sell, lease, mortgage, transfer improve, lease, manage and control all or any part of the property of the above society necessary and convenient for the purpose of the attainment of the adjective of the trust.

5. Trust fund and property.

The sum of Rs. 1000/- (one thousand ) hereinafter called the trust fund collected and entrusted to the trustees as the nucleus of the trust fund. To carry on the aims and objects of the trust funds will be reside by accepting donations, freewill, freewill, offering, endorsements, gifts contributions in India and abroad in case or kind operates moveable and immovable property, bequests from any person , person establishments or generations, institutions, state and central govt. churches, Temple, Mascot etc. for the furtherance of the aims objectives of trust and on such terms and conditions as trust may in its absolute discretion decide.



## 6. THE TRUSTEES

The trustees of the trust shall consist of:-

- i. Those person who signed the trust deed of the trust i.e. founder trustees.
- ii. Such other person /persons who may be invited and admitted by the trustees from time to time.
- iii. The number of trustees shall be not less than two and not more than fifty.
- iv. If any trustee or trustees die or desires to be discharged or become incapable of discharging his duties or adjudicated insolvent or convicted of a criminal offence involving moral turpitude and with imprisonment exceeding six months or is unable to attend meetings continuous for three years. The board of trustees may appoint new trustees in his or their place.
- v. All the trustees unless they voluntarily resigns or otherwise decide shall continue to discharge their duties during the terms of their natural life.
- vi. On a new or additional trustees being appointed and on his signifying his assent to the trust deed, his share in the trustees property shall automatically vest in him along with the other trustees for the purpose of carrying out all the duties and functions of a trustees without prejudice to the trust deeds or writings.
- vii. In case of serious charge of misconduct levelled against a trustees or trustees in relation to the trust concerning the trust estate, trust affairs, the board of trustees shall give him a reasonable opportunity to explain his conduct and or answer the charges levelled against him. If the board arrives at a definite conclusion that the removal of the said trustee would be in the best interest keeping to the object of the trust, the said trustee could be removed after recording reasons in writing for his removal. The decision of the board of trustees in this behalf shall be final and binding and shall not be called in question anywhere.

## 7. POWERS

THE BOARD OF TRUSTEES ARE HEREBY EMPOWERED:

- i. To purchase take on lease or in exchanges or otherwise acquire any property.
- ii. To sell, let, mortgage, dispose of all or any of the property or assets of the trust.
- iii. To, open continue and operate upon any banking account in the name of trust. Such account will be operated by the president or secretary.
- iv. To enter into any arrangement with any government or authority central, state, municipal or otherwise in pursuance of the objects of the trust and to obtain from any such government or authority all right, concessions and privileges which may seem conducive to the interest of any of them.
- v. To undertake and execute charitable trust.
- vi. To receive and collect donations and such helps and assistance as may be offered for the purpose from individuals, associations, state governments, Govt. of India and countries all over the world.
- vii. To invest the moneys of the trust not immediately required for its purpose in any lawful investment, securities or property as per section 11 of Income Tax Act, 1961.
- viii. To employ all such officers and servants as may be required for the purpose of the trust.

- ix. To act agents for any person body society or undertaking in any matter and any law for the furtherance of the objects of the trust.
- x. To open branches of the trust at any place in India.
- xi. To do all such other things as are necessary for the attainment of the above objects of them.
- xii. It is prohibited to apply the income or profit which arising in the promotion of the objects of trust to the trustees in the form of dividends or distribution of the income of profit.
- xiii. Nothing in this clause shall prevent the payment by the trust in good faith of reasonable remuneration to any of its officers and servants or to any persons in return for any services actually rendered in any of the institutions sponsored by the Trust.
- xiv. To pay for any rights or property acquired by the trust and to remunerate any person in any corporate rendering service to the trust and also to pay wages, salaries, other allowances to any person in recognition of service rendered to trust.
- xv. The trustee shall have power to regulate from time to time the objective of this trust to comply with any conditions or requirements of the income Tax Act relating to taxation of income or capital as they think fit so as to obtain for this trust any relief or concession in respect of taxation subject however to the overriding consideration that the object or objects of this trust shall always be a public charitable object including objects of religious nature and such as may be recognised as a public charitable objects as defined in section 2(15) of the Income Tax Act 1961 or any statutory modification, amendment or re-enactment or any law for the time being in force in India.

## 12. MEETINGS OF THE TRUSTEES

A meeting of the Trustees shall be called by the Secretary appointed under clause 7, here in consultation with the president when the affairs of the trust so demand but at least once every year such annual meeting being known as the Annual general meeting of the trust or whenever a meeting is requisitioned by two of the trustees for the time being fourteen days notice shall be given to all trustees for the time being fourteen days notice shall be given to all trustees of all meeting and a detailed agenda of the business to be transacted at all meeting shall accompany these respective notice calling such meeting. At every Annual general meetings of the trust the treasurer shall lay before the meeting report of the activities of the trust since the previous accounting year.

13. Two Trustees personally present at a meeting shall form quorum.

14. At any meeting of the trustees, vote may be given personally or by proxy in favour of another Trustee. The instrument appointing a proxy shall be in such a form as shall be approved by the Trustees. The instrument appointing a proxy shall be delivered to the secretary not less than 24 hours before the time appointed for holding the meeting at which at which the person named in such instrument proposes to vote.

## 15. DECISIONS OF THE TRUSTEES

Except where otherwise provided any question arising as to the proprietary of any transaction of the Trust shall be conclusively settled as between all parties concerned by decision of majority of the number of trustees for the time being.

## 16. THE PROPERTY OF THE TRUST

The trust fund now vested in the trustees and any other funds property hereafter entrusted to the Trustees for the time being or any one or more of them by gift or other means shall from the time such funds becoming so vested be held and administered by the Trustees for the time being in accordance with the terms of this deed.

## 17. INDEMNITY

Every trustee and every person appointed as director or manager or managers under the trust shall be indemnified out of the Trust fund against an losses and expenses incurred in the discharge of his duties except such as shall happen through his own neglect or wilful act or default and no director or manager shall be chargeable with only such money or property as he or they may receive for or in the discharge of the affairs of the trust and each one shall be answerable only for his own acts neglect or defaults and not for those of any other person.

## 18. VARIATION OF THE TERMS OF TRUST

Alterations to the clauses of this Deed shall only be made at a meeting of the trustees and notice of two calendar months such notice shall be accompanied by details of the proposed alterations shall be subject to confirmation at a second meeting of the Trustees held not earlier than two months after the first meeting.

month but not later than two calendar months after the first meeting clauses 4 and 21 are immutable. Other clauses may be altered by the votes of two thirds of the number of the trustees. All alterations shall be confirmed by "Deed of variation of trust."

19. THE SUITS

The trust may sue or be sued in the name of the president or his/her nominee who shall at the expense of the trust be compete to employ lawyers and attorneys for the purpose of prosecution and defence of suit and legal proceedings and so sign plants, written statements, vakalatnamas as well as file or receive back documents and moneys belong to or meant for to trust and take all necessary steps as may deemed fit and expedient in the interests of the trust.

20. A Circular resolution issued by the Secretary in Consultations with the president on any subject and signed by a majority of the members of the board of trustees shall in all respects be as valid and binding as a resolution passed at a meeting of the board of Trustees, duly convened and constituted and such resolution shall not be deemed invalid by reason of want of notice or any other cause whatsoever

21. DISSOLUTION AND DISTRIBUTION OF ASSETS

If at any time, the continuation of the trust shall appear to the trustees for the time being not to serve any useful purpose of the trust shall forthwith be wound up and any assets remaining after the satisfaction of all lawful liabilities and claims against the Trust the same shall under no circumstances be paid to or distributed among the trustees for the time being or former trustees or made available for the personal benefit of anyone but shall be given to some other registered society or trust having the same subject similar to those of the trust to be determined by the trustees for the time being or in default thereof by the court of law having jurisdiction in the matter. 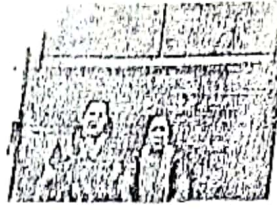

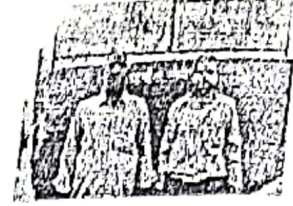
